## **FUNDING:**

A History of the Hong Kong Professional Teachers Union supported by a research grant of HK\$534,000 from the Hong Kong Professional Teachers Union, 2011-2014.

Centre for Religious and Spirituality Education at the Hong Kong Institute of Education. During 2006, donations totaling some fifteen million Hong Kong dollars (ca. Can\$2.5 million at the exchange rate of the time) was raised from Daoist, Anglican, Catholic and Buddhist organizations in Hong Kong to establish the Centre for five years (2006-2011). Most of this sum was eligible for the matching grants of the University Grants Committee of Hong Kong.

Hong Kong Life Stories Series. Ca.
